### FY25 Non-Instrumented Drug Test (NIDT)

Dear Vendor,

The United States Pretrial Services Office for the District of New Jersey is seeking competitive quotations for the purchase of Non-Instrumented Drug Testing Devices (NIDTs) for Fiscal Year 2025 (4/22/2025-9/30/25). Specifically, we are seeking competitive quotations for an 11-panel dip device that includes the below testing panels and meets the noted cut-off levels.

In addition, we are seeking competitive quotations for a single panel buprenorphine (5ng/ml cutoff) dip and a single panel ETG dip.

Supplies must be received within 14 business days of order being placed. Please indicate if specimen cups are included in pricing and if there are not, what the additional cost would be. **All competitive quotations should be submitted to my attention no later than 5pm on Tuesday, April 22, 2025.**
